We welcome our esteemed judge, Mrs Lorraine van Loggerenberg, who qualified as a Breed judge in 2020. With this judging appointment being Lorraine's 7th official appointment, we are honoured to have such a knowledgeable and esteemed judge at our show!

Lorraine has been involved in breeding and showing of GSD's for over 20 years. She started breeding under the kennel name Zagroshill with her mother Kathy Hume and Partner Maria da Silva.

Lorraine, with her husband Nico and her mother Kathy, registered the kennel name Keashan in 2005 producing the first A litter on 1 May 2005. The kennel name Keashan is a combination of both Lorraine's children names namely Shannon and Keagan. Keashan kennels achieved Diamond Breeder status in 2019.

Lorraine's first big success was obtaining a VA(SA) grading with her bitch, Eicha of Zagroshill in 2003. To date the Keashan kennel has bred four VA(SA) females, namely Havoc, Rebel, Buffi and Izzy.

She is also a very busy tattooist and a long serving Breed Supervisor of Johannesburg GSD Club. And Lorraine is always willing to share her breeding and showing knowledge and experience with novice participants.

Awards

V - "Excellent" grading awarded at shows other than the National Show to dogs over 24 months of age which meet the strictest breed standard requirements regarding construction, appearance, and temperament and which have passed a Federation recognized HD scheme.

SG - "Very Good" grading awarded to dogs over the age of 12 months and who meet the breed standard in most requirements regarding construction, appearance, and temperament.

G - "Good" grading awarded to dogs over the age of 12 months with small failures regarding construction, appearance, and temperament but that largely meet the breed standard requirements or to dogs and bitches not yet sufficiently developed.

A - "Sufficient" awarded to dogs over the age of 12 months with noticeable faults in construction and appearance or to dogs that show a slight negative response to a gunshot.

M - "Faulty" awarded to dogs over the age of 12 months with prominent faults.

U - "Insufficient" grading awarded to dogs over the age of 12 months with prominent faults, bad temperaments or which are scared or nervous or to dogs that have failed the gunshot test. Similar to a "M" grading, but to a greater degree. The Federation offices should be immediately notified by the committee and a reason clearly stated. This grading can only be overturned by a breed show but does not influence previous gradings.
