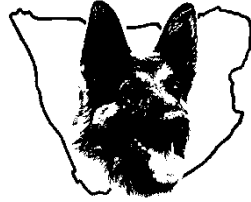

Our Judge: Frikkie van Kraayenburg



Frikkie is a Founder Member of the Federation. At the beginning of 2010 he qualified as a full German SV judge and is also the Chairman of the Breed Judges' Committee and President of the Federation of South Africa.

He started the kennel Grehenheim (originally spelt Grähenheim, meaning home of the crow) in 1979 and it became a joint venture after he married Sonia. The kennel was the first to be awarded the Breeders' Diamond Medal Award in 1999 and in 2015 a Triple Diamond Award. This year the Grehenheim kennel reached another benchmark by being awarded the first Quadruple Diamond Breeders Medal.

Breeding and genetics have always been his passion and he also breeds Purebred Production Chickens.

He has judged in England, India, New Zealand, Australia, Kenya and Zimbabwe.

His hobbies include wildlife photography, scuba diving and reading.

AWARDS

- “V”:** *Excellent – awarded to dogs and bitches over 24 months of age who meet the strictest Breed Standard requirements regarding construction, appearance, temperament and breeding requirements including the official “A” stamp on the pedigree.*
- “SG”:** *Very Good – awarded to dogs and bitches over the age of 12 months and who meet the Breed Standard in most requirements regarding construction, appearance, temperament and breeding requirements.*
- “G”:** *Good – awarded to dogs and bitches over the age of 12 months with small failures regarding construction, appearance and temperament, but that largely meet the Breed Standard requirements or to dogs and bitches not as yet sufficiently developed.*
- “A”:** *Sufficient – awarded to dogs and bitches over the age of 12 months with noticeable faults in construction and appearance or those that show a negative response to a gunshot.*
- “M”:** *Faulty – awarded to dogs and bitches over the age of 12 months with prominent faults*
- “U”:** *Insufficient – same as for “M” but to a greater degree. When this grading is awarded to any dog or bitch at a breed show, the Federation Office must be notified immediately by the Show Holding Committee. The reason for the award must be clearly stated. This grading can only be overturned by participation in a Breed Show. This procedure will not influence valid grading previously obtained in a show ring.*

Dogs with bad temperament and those that are scared or nervous, may only be given “M” or “U”.

Dogs and bitches under the age of 12 months cannot be graded and will be described by the judge as “Very Promising”, “Promising” or “Less Promising”.
